SOP Guidelines for Trial & Selection 2020-21

It is mandatory for all to follow the below given guidelines-

1. All players, support staff and officials must submit the **consent form** to participate in the selection trials before entering the playing area.
2. All players, support staff and officials must download and install **Arogya Setu** app before entering the trial selection area/venue.
3. All players, support staff and officials must be compulsorily screened using non-contact thermometer before entering the trial selection area/venue facilitated by Arunachal CA.
4. **All players, support staff and officials must be compulsorily wear facemask covering nose and mouth before entering the trial selection area/venue.**
5. All individuals and players kit bag should be compulsorily sanitized upon arrival and after every use using disinfectant spray.
6. **No Spectators, Parents and other visitors** allowed inside the trial venue area at any time of the day.
7. All players, support staff and officials must carry their personal sanitizer bottles and use them as frequently as possible.
8. Hand hygiene facilities to be made available at the venue of trial.
9. All surfaces that can be potentially be touched by multiple individuals should be sanitized at regular intervals during the day.
10. All players, support staff and officials must follow Social distancing rules during selection trials.
11. **Use of Saliva should not be used** on the cricket balls. Individual balls should be provided and need to be sanitized before reuse by other players.
